In response to the Court's inquiry below, I offer the following:

1. This response is agreed by the Co-Trustees and Carole Brunsting. Ms. Bayless has not been able to respond by the time of this email correspondence; a fact not intended as a criticism of Ms. Bayless. The practice of law is challenging, and Ms. Bayless is entitled to the benefit of the doubt that her schedule did not permit a response by the time this correspondence was issued. With that said, I am confident Ms. Bayless will not have a material disagreement with what is provided below.

2. Notwithstanding that Ms. Bayless may have some additional input to the information in this correspondence, the term "Beneficiaries" as used in this correspondence means the Co-Trustees, Carl Brunsting, and Carole Brunsting, The agreement of Candace Curtis is not required, because she is no longer a beneficiary under the Trusts.

3. The case remains on the Court's docket because of an injunction that is in place, and because there is not yet a final judgment that resolves all issues as to all parties. More specifically, the reasons include, but are not limited to, the following:

a. An injunction remains in place that requires Court approval for certain distributions. The present injunction was issued by U.S. District Court Judge Hoyt on April 19, 2013. The federal court remanded/transferred this matter to this Court on May 15, 2014. On June 3, 2014, this Court accepted all pleadings and <u>orders</u> of the federal court.

b. By way of example that approval is required for a distribution, in January 2022, the Court ordered a \$100k health related distribution for the benefit of Carole Brunsting. Since the injunction has not been lifted, the Co-Trustees, Carl Brunsting, and Carole Brunsting believed Court permission was required for the expenditures to the Tenant/Farmer and the agreed initial distributions of \$30k to Carl Brunsting, Amy Brunsting, and Anita Brunsting. *See* attached order regarding same.

c. The Beneficiaries expect to enter into a comprehensive settlement that will allow the -401 to be closed/made final.

d. There are outstanding claims by the Estate/Trust to be resolved, so that this case can get to a final judgment. By way of example, and not as a limitation:

1) There is the need to resolve who will be or is the Successor Executor of the Estate.

2) There is the need to resolve the claims against the Vacek & Freed defendants, and who owns these claims, whether it be the Estate or the Trust.

4. Per my email earlier this morning, there is plenty of liquidity to make the disbursements to the Tenant/Farmer, and the initial \$30k distributions to Carl Brunsting, Amy Brunsting, and Anita Brunsting, as referenced in the pending motion, and per the attached proposed order. More specifically, as of November 30, 2022, the Trust is holding 145 acres of Iowa farm land worth \$3.420M, and \$1.604M in liquid assets, such as cash, brokerage assets, etc. Total assets owned by the Decedent and Survivor's trusts are currently \$5.024M. Please note the assets remain subject to fluctuations of the investment markets, as to the financial accounts, and the real estate market, as to the value of the Iowa Farm.

I hope the foregoing resolves the Court's concerns. As reflected in the pending motion, the Beneficiaries request that the Court sign the attached order.
