Order Granting Authority to Retain Iowa Counsel

Carl Brunsting, Carole Brunsting, and the Co-Trustees, Anita Brunsting and Amy Brunsting, filed an agreed motion for the Co-Trustees to have the authority to retain Iowa counsel. The motion is GRANTED. It is, therefore,

ORDERED that the Co-Trustees are GRANTED the authority to retain an Iowa attorney and/or law firm on such terms and conditions as the Co-Trustees consider reasonable and necessary regarding the sale and/or distribution of all real property in Sioux County, Iowa owned in whole or in part by the Elmer H. Brunsting Decedent's Trust ("Decedent's Trust").

It is ORDERED that the Co-Trustees shall pay from the Decedent's Trust the legal fees of the Iowa attorney and/or law firm as follows:

- A. A retainer not to exceed \$7,500.00.
- B. Legal fees not to exceed \$7,500.00 in the aggregate.
- C. Law firm expenses not to exceed \$1,500.00 in the aggregate.

It is further ORDERED that legal fees and/or expenses that exceed the foregoing aggregate amounts shall be subject to Court approval; provided, however, Court approval is not required if Carl Brunsting, Carole Brunsting, and the Co-Trustees agree to the amount(s) that would have been subject to Court approval.
