pending before the 1ST Court of Appeals, the Co-Trustees provide the following:

- 02/14/2019 Probate Court denies Curtis' plea to the jurisdiction.
- 03/16/2019 Deadline for Curtis to appeal the denial of her plea to the jurisdiction.
- 02/25/2022 Probate Court grants the Co-Trustees motion for summary judgment. The summary judgment was final as Curtis.
- 03/27/2022 Deadline for Curtis to appeal the summary judgment granted in the Co-Trustees favor.
- 05/18/2022 Curtis files a notice of appeal as to the plea to the jurisdiction, summary judgment, and all matters ancillary to the probate of Nelva E. Brunsting.

07/03/2023 Curtis files her initial brief to the 1ST Court of Appeals.

- 10/02/2023 Co-Trustees and Carl Brunsting file their response brief with the 1ST Court of Appeals.
- 11/01/2023 Curtis files her reply brief to the Co-Trustees response brief.
- 01/08/2024 1ST Court of Appeals sets the case on its submission docket. Curtis' request for oral argument was denied.
- 02/22/2024 1ST Court of Appeals issues a notice of intent to dismiss for lack of subject matter jurisdiction, and orders Curtis to submit additional briefing within fourteen (14) days.
- 03/07/2024 Curtis files a response brief with the 1ST Court of Appeals on the issue of appellate court jurisdiction.
- 06/06/2024 1ST Court of Appeals orders the Co-Trustees and Carl Brunsting to file a reply to Curtis' response on the issue of appellate court jurisdiction. After granting the appellees an extension to file the reply, the reply is due 06/28/2024.
