Dear Ms. Curtis:

We appreciate the concerns raised in your complaint. However, after conducting a thorough investigation into the allegations that you raised against the judge, the Commission determined, in its discretion:

- ☒ there was insufficient evidence to support a finding of judicial misconduct.
- ☐ the decisions of the judge in your case were discretionary and not subject to review by this agency.
- ☐ the allegations, even if true, did not constitute a violation of the Texas Code of Judicial Conduct or Tex. Const. Article 5, Section 1-a, (the constitutional provisions under which a judge can be disciplined by the Commission.)

Although we are prohibited by law from disclosing the specifics of our investigation, please be aware that our investigation can include, but is not limited to, consideration of the supporting information submitted by a complainant, interviewing other individuals with knowledge of the matters addressed in the information you provided, and reviewing court records and pleadings. In conformity with the specific constitutional provisions, statutes and canons, which limit the actions that may be considered judicial misconduct, the Commission voted to dismiss your complaint.

However, if you have additional evidence (e.g., witness statements, affidavits, hearing transcripts, etc.) that you believe may not have been reviewed or considered by the Commission, you may request, **one time only**, a reconsideration by the Commission. Please provide your written Request for Reconsideration, along with photocopies of any documents you wish the Commission to review, **no later than** thirty (30) days from the date of this letter. Be sure to reference the above-listed file numbers in your requests.

While not all complaints result in a finding of misconduct, we appreciate your concerns and your interest in assisting us in maintaining the high ethical standards of the Texas judiciary. Thank you for bringing these issues to our attention.
