Agreed Final Judgment Closing Administration

Before the Court is the oral *Agreed Motion for Final Judgment* requested in open court by: (1) Carl H. Brunsting, Carole A. Brunsting, Amy R. Brunsting, and Anita K. Brunsting (hereinafter the “Remaining Beneficiaries”); and (2) the Co-Trustees, Anita K. Brunsting and Amy R. Brunsting, to close the Estate of Elmer H. Brunsting, Deceased (the “EHB Estate”).

The Court finds as follows:

- 04/12/2012 Application to probate Decedent’s Will was filed.
- 08/12/2012 Decedent’s Will admitted to probate and Carl H. Brunsting is approved as the Independent Executor to serve without bond.
- 04/05/2013 The Court approved the inventory, appraisal, and list of claims.
- 04/05/2013 The Court issued a drop order.
- 02/19/2015 Carl H. Brunsting moved to resign as Executor of the Estate, but the motion was never heard.
- 06/02/2025 The Remaining Beneficiaries and Co-Trustees waive the filing of a verified account and/or closing report.
- 06/02/2025 The Remaining Beneficiaries and Co-Trustees waive issuance of citation and/or a notice to close the EHB Estate.
- 06/02/2025 The Remaining Beneficiaries and Co-Trustees agree all the debts known to exist against the EHB Estate have been paid, there is no pending litigation under C.A. No. 412248, no material matter related to the EHB Estate has occurred since February 19, 2015, when Carl H. Brunsting moved to resign as Independent Executor, there are no assets in the possession of the Independent Executor, and there is no further need for an administration.

Having considered the agreed motion of: (1) the Remaining Beneficiaries of Carl H. Brunsting, Carole A. Brunsting, Amy R. Brunsting, and Anita K. Brunsting; and (2) the Co-Trustees, Anita K.
