Report, is also the Temporary Third-Party Guardian of the Estate Pending Contest of the Ward, filed the Inventory, Appraisement and List of Claims on November 3, 2017, as to the assets of the Ward's Estate, which was approved by this Court on November 6, 2017. A Final Account will be filed with this court.

V.

During the last year, the Guardian saw the Ward numerous times, having last seen the Ward on December 23, 2017; the Ward died at Houston Hospice, Texas Medical Center, on December 24, 2017, at the age of 93 years.

VI.

The Ward was under regular care of several physicians and nurses. During the four months that Temporary Guardian served as such, the Ward was treated or evaluated by physicians at The Gardens of Bellaire, St. Luke's Hospital and Houston Hospice Medical Center.

VII.

Therefore, the Temporary Guardian Pending Contest of the Person of MURIEL LUBA MINTZ, Ward, believes her powers should be terminated and that the Guardianship of Muriel Luba Mintz should be closed.


