MOTION FOR INDEPENDENT MEDICAL EXAMINATION

This Motion for Examination under Rule 204 of the Texas Rules of Civil Procedure and Section 1101 of the Texas Estates Code is filed by **Donald M. Mintz** ("Movant"), Applicant for Guardian of the Person and Estate of **Muriel Luba Mintz** ("Proposed Ward"), who shows in support:

- 1. Movant believes the Proposed Ward should be evaluated by an independent psychiatrist for the purpose of determining the degree of mental and physical incapacity of the Proposed Ward and the prognosis.
- 2. Good cause is shown for an examination of the Proposed Ward because her degree of mental and physical incapacity is in controversy in this proceeding.
- 3. Movant moves that the Court designate the time, place, manner, conditions, and scope of the examination to be conducted by an independent psychiatrist.
- 4. Movant requests that the costs of the examination be paid out of the assets of the Proposed Ward's estate.

Mintz, Applicant for Guardian of the Person and Estate of Muriel Luba Mintz, prays that the Court order the Proposed Ward to appear before an independent psychiatrist for the purpose of undergoing an independent mental examination in accordance with Rule 204 of the Texas Rules of Civil Procedure and Section 1101 of the Texas Estates Code to determine the degree of mental and physical incapacity and that a written report be filed with the Court and provided to Movant's attorney and that the costs of such examination be ordered paid as deemed proper by the Court.
